Frontier Lithium Resources Inc. (Frontier) is holding a Public Open House in Red Lake, and we would like you to join us to learn more about the Project, meet the Project Team, ask questions and share your feedback. Light refreshments will be provided.

The PAK Lithium Project a proposed open pit mine with supporting facilities located in a remote area of northwestern Ontario, approximately 175 km north of Red Lake. The property contains 2,219 hectares of land on three mining leases and the property is owned entirely by Frontier. Currently, construction is anticipated to begin in 2028, with the mine being operational by 2031. The intent of the Open House is to provide a general overview of the Project and discuss the use of diesel generation during construction and the installation of a transformer substation on-site to support future mining operations, as well as to present the general closure concepts for the mine post-operations.

During construction, less than 5 MW of diesel generation will provide a temporary power source during the construction phase and would later provide supplemental power during operations. To provide a permanent power source to the mine during the operations phase, Frontier proposes to construct a new 115 kV transformer substation for interconnection with the provincial power grid via the Wataynikaneyap Transmission line. These activities require the completion of the Class EA for Transmission Facilities and the Environmental Screening Process for Electricity Projects (ESP) in accordance with the Ontario Environmental Assessment Act.

Once the mining operations are complete, the mine will be closed and the land rehabilitated following the strategies outlined in an approved Closure Plan developed under Ontario Regulation 35/24, Rehabilitation of Lands under Part VII of the Mining Act.


